WHAT DOES RUMAMEND CREAM CONTAIN

The active substances are Geranium Oil (2.5%), Magnesium Chloride (1.2%) and Castor Oil (0.5%)

WHAT IS RUMAMEND CREAM USED FOR

Rumamend cream is intended to aid with mobility in painful muscles and joints. Due to its anti-inflammatory and analgesic properties it may also reduce pain and inflammation due to sunburn.

BEFORE YOU USE RUMAMEND CREAM

Do not use this product:

- If you are hypersensitive (allergic) to any of the ingredients listed
- On open wounds or any areas where it may irritate mucous membranes
- If you have hyper sensitive skin

Contraindications

The safety of this product during pregnancy has not been established and should therefore be avoided

Special care should be taken in the following instances, always consult with a pharmacist or other health care professionals

- Excessive sunburn where blistering and open wounds may be present

PREGNANCY AND LACTATION

- Safety during pregnancy and breastfeeding has not been established

USING OTHER MEDICATIONS WITH RUMAMEND CREAM

Always tell your healthcare professional if you are taking any other medicine. (this includes complementary or traditional medicines).

- Avoid applying this cream in conjunction with any other preparations to ensure that the best results are achieved.

HOW TO USE RUMAMEND CREAM

Apply 2-4 hourly to affected areas. It should be noted that the cream has to be massaged deep into the skin to avoid irritation. Not to be used on open wounds.

POSSIBLE SIDE EFFECTS

Skin irritation, redness, minor rash or itching may occur. Mucous membranes such as the eyes, nose and mouth should be avoided.

Not all side effects reported for Rumamend are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, please consult your pharmacist or other health care professional for advice.

STORING AND DISPOSING OF RUMAMEND CREAM

Store at or below 25 °C in a dry place
Protect from direct sunlight
Do not use after expiry date stated on outer packaging

Any unused or expired medicine should be returned to your pharmacist for the safe and responsible destruction thereof. Do not dispose of unused medicine in drains or sewage systems.

Rumamend Cream is available in tubs of 50 g and 125 g.

Rumamend is presented as a white cream with a distinct Geranium scent.
